Course Name: TOURISM & TRAVEL LAW

Year of Study: THREE Course Code: BTT3240

Course Description:

This course covers the main areas of law relating to the tourism and travel industry, legal and policy issues for managers in the industry that have primary relationships with tourists, guests/patrons, employees and the government. The course also covers the legal issues affecting the operations of the travel and tourism industries including aspects of hospitality law, occupier's liability, negligence, regulation of the travel industry, the ingredients and defences to the tort of negligence as well as the relationship between the innkeeper and guests.

Course Objectives:

This course is intended to provide students with the knowledge of the legal aspects of the travel and tourism business. At the end of the course, students should be able to appreciate the industry regulatory framework, the statutory requirements for operating tourist facilities, common law, statutory and contractual duties of the various players in the tourism business and issues of negligence as they relate to the subject. Students are advised to read the main texts and the reference books below for an overview of the course.

Learning outcomes:

- At the end of the course, students should be able to conclude valid and enforceable tourism and travel contracts; and
- To run travel and tourism business along contemporary legal principles and procedures.
