#### A case study on Secure Mobile payments

Mobile Payment (M-payment) is a critical component in m-commerce applications. According to the Wireless World Forum, M-payment on mobile devices will provide excellent business in coming years (Jerry Gao, 2005). Payment systems can be used by wireless based merchants, content provider, information and service providers to process and support payment transactions. Thus, the study of mobile payments is crucial to the success of mobile commerce. Four properties are always considered essential for a secure transaction. These properties are authentication, confidentiality, integrity, and non-repudiation (Seema Nambiar, 2004). losely coined as CIA/N. Authentication is concerned with verifying parties' identities in a communication and confirming that they are who they claim to be. *Confidentiality* is about ensuring that only the sender and intended recipient of a message can read its content. *Integrity* is concerned about ensuring the content of the messages and transactions not being altered, whether accidentally or maliciously. Non repudiation is about providing mechanisms to guarantee that a party involved in a transaction cannot falsely claim later that she did not participate in that transaction (Seema Nambiar, 2004).
